HC20027	Fail to ensure community centre in England closed during coronavirus emergency period
HC20028	Fail to ensure crematorium in England closed during coronavirus emergency period
HC20018	Business fail to cease selling food and drink on premises in England during coronavirus emergency period
HC20019	Fail to close business or premises not permitted during emergency coronavirus period in England
HC20020	Participate in gathering in public of more than two people in England during coronavirus emergency period
HC20021	Contravene requirement given by relevant person during emergency coronavirus period in England
HC20023	Fail to close place of entertainment during Coronavirus
HC20024	Business selling food/drink off premises in England, sell for consumption on premises in coronavirus emergency period
HC20031	Stay overnight other than place of living in England, without reasonable excuse
