



DIRECTION

Pursuant to Section 12 Public Order Act 1986

To: [REDACTED] - The Organiser of supporters of 'The Rape of Britain' documentary and all persons taking part in the public procession

I, Chief Constable P. Mills, West Mercia Police:

With reference to the Public Procession planned to commence at 1430hrs at Telford Central Train Station, Telford on Saturday 29th January 2022, in accordance with your notification dated Tuesday 4th January 2022 and the powers conferred on me in Section 12 Public Order Act 1986, and my reasonable belief that the time, place and circumstances in which the procession is to be held, and its proposed route, may result in serious public disorder, serious damage to property, serious disruption to the life of the community or intimidation of others.

Give the following directions, imposing on you, as organisers, and upon all participants, the following conditions:

1. Those participating in the procession will be expected to assemble peacefully at the following location Telford Central Train Station, Telford by 1400hrs on 29th January 2022
2. **The route of the outbound procession from the Railway Station to Blue Willow car park** shall be as follows:
Telford Central Train Station – Onto the footbridge that crosses the A442 & A5, RIGHT onto Ironmasters Way – LEFT into Forge Gate – RIGHT into Woodhouse Central – RIGHT at the Odeon entrance area and immediately LEFT onto the pathway /cycle path that runs alongside Woodhouse Central following this pathway under the underpass and into the Blue Willow car park. See MAP overleaf.

The route of the inbound procession from the Blue Willow car park to the Railway Station at the conclusion of the assembly shall be as follows:
Blue Willow car park, under the underpass following this pathway/ cycle path that runs alongside Woodhouse Central, immediately RIGHT onto Woodhouse Central then LEFT into Forge Gate – RIGHT onto Ironmasters – LEFT onto the footbridge that crosses the A442 & A5 – into Telford Central Train Station.
3. Participants must follow the directions of a constable - even if those vary the prescribed route as listed above
4. The outbound procession shall commence at 1430hrs, Saturday 29th January 2022.
The inbound procession shall commence at 1700hrs, Saturday 29th January 2022.
